The public services garage is a definite must-see at this year's Open House. The Road Department joins the action this year in a big way – *SO BIG* that kids will have to climb up some *BIG* stairs to get into some *BIG* equipment to enjoy a *BIG* 

experience! If kids can maneuver the steps, they can sit at the controls of a large road grader and have their photos taken. They may also take a ride in a snow plow truck. You will have an opportunity to see drawings of the proposed new Public Services Facility (see insert inside this newsletter) and take a

tour of the existing facility.

The Water Department's booth will be motivational as well as educational. Both children and adults will understand the importance of protecting our waterways after they take part in an interactive demonstration showing how everyday activities can pollute our waterways. The department will also have some of their maintenance equipment on hand. Climb aboard the big vactor cleaning truck and get an opportunity to take a look underground into our sewer system with state of the art video equipment.

At the Fire Station, you'll still be able to watch U of M's helicopter land and talk to the pilot. You will also be able to see your long-time favorite fire demonstrations and children can practice their "Stop, Drop and Roll" techniques. There will be refreshments, videos, ladder trucks and all kinds of fun stuff for kids of all ages. But, there's a serious message, too. The Bloomfield Township Fire Department is joining forces with fire departments, schools and safety groups across North America to reinforce a simple but lifesaving message, "It's Fire Prevention Week; change your smoke detector batteries!"

Or, maybe you're interested in the health of our watershed. If so, attend the Fall Bug Hunt, sponsored by Friends of the Rouge, on Saturday, October 16, 9:00 AM - 2:00 PM. Volunteers will sample two different sites in the headwaters of the Rouge River and sort through samples of bugs (aka: benthic macroinvertebrates). The abundance and diversity of the organisms provide information on the health of the stream. "Our primary objective is to reach out to the public with information they can use to stay safe from fire," according to Lt. Insp. Doug Brown. "We want them to remember three things: They need working smoke alarms in bedrooms and on every level; they need to plan and practice home fire drills; and if fire strikes, they need to get out and stay out."

Vince and Larry, everyone's favorite crash test dummies, will be welcoming folks to the Police Department again. "This year, for the first time, we've arranged for the Oakland County Sheriff's armored vehicle to roll in and let people take a look," said Sgt. Phil Langmeyer. "As we've done before, we're going to offer to check parents' and grandparents' vehicles for the proper installation of child and infant car seats. We'll also have rides in patrol cars, K-9 demonstrations and tours of the animal shelter and police facility."

If you've attended the Open House before, come back this year to see what's new. If you haven't experienced the free family fun, this year is a great year to start a tradition!

## A Reminder for Fall Landscaping Projects

Are you planning a landscape improvement this fall? In order to protect established drainage patterns, the Township must regulate the addition of soil fill on residential property.

If you bring in fill soil on your property you must first obtain a **Soil Fill Permit** from the Township. This includes construction projects involving building additions as well as landscaping. Please contact the

## A Note From the Supervisor:

he Ryder Cup Matches, shown on television sets and reported in magazines and newspapers all around the world, brought Bloomfield Township into the homes of millions of people. This prestigious, international event took years of planning and required the cooperation of many government and law enforcement agencies and private businesses working with the Township, the PGA and Oakland Hills Country Club.

Every area of Township services was involved. Our Police Department was the lead law enforcement agency and was charged with the ultimate responsibility of providing for the safety and security of participants, visitors and residents. The Fire Department headed up comprehensive Emergency Management Planning. EMS personnel

planned for every imaginable medical emergency response. Our Planning and Building Department reviewed plans for the many private events and, along with the Fire Department, inspected the 320,000 square feet of temporary structures built on the grounds of Oakland Hills. Our Code and Ordinance Enforcement personnel were busy making sure residents and visitors complied with Township requirements. The Township created a telephone hotline and email service which, combined, responded to more than 800 inquiries. Road Department workers put out the welcome mat by installing much needed new landscaping in road medians near the golf course. The Water Department made sure that the water supply was adequate for safe drinking and fire protection. The Information Technology Department supplied security and law enforcement officers with communications devices as well as maps and other technology.

We are gratified that our staff's planning and hard work contributed to the success of the Matches, but we are especially grateful for the understanding and patience of our residents. There is no way an event of this magnitude can be held without an impact on the community. Those closest to the golf course experienced the most inconvenience as they saw their neighborhoods changed, at least temporarily, into a construction zone. Many homeowners needed a permit to drive into their own neighborhood. Lawn service and residential construction projects were delayed. Large family, religious and social gatherings required extra arrangements to comply with parking restrictions. Throughout the Township, traffic was heavier than usual. Routine errands and workday commutes became complicated.

On behalf of the Board of Trustees, I would like to thank Oakland Hills Country Club and the PGA for supporting our efforts and for reimbursing the Township for our direct expenses. State Representative Shelley Goodman Taub merits special thanks for securing a grant which will cover the Township's additional costs.

Most of all, I would like to thank you, Bloomfield Township residents, for understanding the necessity of the plans that caused your inconvenience. We all know it wasn't easy, but your support, cooperation and patience helped Bloomfield Township look great in the eyes of the world!
